#### MEETING MINUTES

Regular Meeting: Attendees: Members Johnson, Mills, Valles, Urbanczyk, and Dr. Daughtery attended online.

1-3. Order, quorum, notice, Joan called to order, verified quorum and notice.

4. Public Comment: Dr. Daughtrey raised concerns regarding the small acre tracts being sold in Brewster County with no oversight as to water supply or well restrictions and the need to address procedures to allow comment from the community.

5. Minutes from 1/27/22 were approved contingent upon addition of amendment to include all board member names who were present (ALL). This was omitted due to new GM typing the minutes and not having been present at that meeting and no role having been taken on the recorded meeting. Member Urbanczyk moved to accept, Member Mills seconded, all in favor. Minutes from 2/17/22 were approved, Member Mills moved, Member Valles seconded, all in favor.
