## Regular Meeting

- 1. Meeting called to order by Chairman Johnson at 8:10 a.m.
- Determination of Quorum: In attendance were Joan Johnson, Tim Leary, Colton Foster, Ambrosio Valles, Rush Warren, Tom Mangrem, Kevin Urbanczyk and Robbyn Hill. Public attendees were Sydney Bauer and Adam Jones. Sam Ballard, Dr. Stephen Daugherty and Gideon Retief with Willowcreek RV attended via Go to Meeting. Chair Johnson verified quorum.
- 3. <u>Proof of Notice of Meeting</u> proof of Notice of the meeting was posted appropriately and timely with the Brewster County Clerk's Office and Website.

- 5. <u>Discuss/Act on: Approval of Minutes</u>-Regular meeting, October 19, 2023, Motion to approve was made by Director Mangrem, 2<sup>nd</sup> made by Director Leary. Motion passed.
- 6. <u>Discuss/Act on: Well Applications and Approvals, Drilling reports, State Data</u> GM Hill administratively approved:
  - 6 applications to drill exempt wells from Will Wood, Cathedral Mountain, 20,000 acres (Arrowhead);
  - 1 from William Donnell, Donnell Ranch, 40,000 acres, East Marathon, 3.79 miles from rest stop (Skinner);
  - 1 from Joe Franklin, Sierra La Rana, 25 acres (Arrowhead).
  - 1 well report received from Skinner for Gary Dunshee, Hwy 118, 100 gpm
- 7. <u>Closed Session</u> None
- 8. <u>Discuss Production Permit application received from Willow Creek Camping</u>- Application to drill a non-exempt well to serve commercial 6 RV spots was discussed. This is in Terlingua Ranch on 20 acres. Motion made by Director Foster, 2<sup>nd</sup> by Director Warren to drill the well. GM Hill will review Production Permit application after well is drilled and will be discussed at meeting on December 21, 2023. If applicable a hearing date will be set. Upon further review of the documentation submitted, it was determined that there was missing or inaccurate information. At this time, Chairman Johnson made a motion to rescind the drilling approval, seconded by Dr. Urbanczyk. A vote was taken and motion carried. The drilling application will be revisited when corrected paperwork is received.
- 9. <u>Discuss Updates on Rules Changes</u> Chairman Johnson discussed the progress made by the committee. Attorney Trejo will email completed draft by end of the week and this draft will be emailed to directors.
